Curry College exclusively offers Education licensure programs in Massachusetts and is not authorized to provide licensure endorsements for or by any other state or territory.

Interstate Agreement – National Association of State Directors of Teacher Education and Certification

Curry College, as an institution of higher education operating in the Commonwealth of Massachusetts, operates under the National Association of State Directors of Teacher Education and Certification (NASDTEC) Interstate Agreement. The **NASDTEC Interstate Agreement** facilitates the mobility of educators among the states and other jurisdictions that are members of NASDTEC and have signed the Agreement. Although there may be conditions applicable to individual jurisdictions, the Agreement makes it possible for an educator who completed an approved program and/or who holds a certificate or license in one jurisdiction to earn a certificate or license in another state or jurisdiction. Receiving states may impose certain special requirements which must be met in a reasonable period of time. Receiving states may also have different criteria for experienced teachers and inexperienced teachers.

The below chart directs readers to individual NASDTEC pages for each state for an overview of the requirements for out-of-state licensure requirements and what a graduate from a Massachusetts based Education licensure preparation program and license holder would need to do in order to obtain a license in a member state. *For states that are not members of NASDTEC, Curry College has not determined whether the College's curriculum meets the educational requirements for initial educator licensure in a given state or territory and prospective students should consult with the appropriate educational authority in that state to determine whether or not a Massachusetts based Education licensure prep program would satisfactorily meet the requirements to obtain an Educator's license in that state or territory.*
