MACJ Cohort Starting Fall 2018

Courses are delivered through a hybrid model which combines in-class instruction with online learning. In-class lectures are held from 5:30 p.m. – 10:15 p.m. and are offered at both the Milton and Plymouth campuses. Students enroll in and complete one eight week course each term. Milton students will meet on Tuesday evenings; Plymouth students will meet on Thursday evenings.

Application Deadline

To receive priority consideration, submit all materials by July 15 to begin in September. Applications received after July 15 will be reviewed on a space available basis.

MACJ Program Tuition

The MACJ program offers attractive, fixed tuition pricing to help students manage their tuition payments. Our fixed tuition allows students to enter the program knowing the MACJ tuition will not increase as long as they maintain continuous enrollment. The MACJ program charges no additional course fees. Expenses for textbooks and course related materials are not included in the tuition. For planning purposes, MACJ students that entered in Fall 2017, the fixed tuition was \$22,990 (approximately \$742 per credit X 31 credits). Fall 2018 will be announced in late May 2018.

Tuition Billing Process

Approximately five weeks prior to the start of the fall, spring, and summer semesters, students will be mailed a tuition bill for their semester coursework. Tuition payments are due within 30 days of the billing date specified on the bill and must be paid in full prior to the start of each semester.

Curry College offers a Direct Billing option for students whose employer or other third party organization will be paying the College directly for their classes. Students who plan to use the direct billing option are required to provide appropriate documentation, such as a purchase order or voucher. Tuition Payment

Tuition can be paid by check or credit card. VISA, Discover, MasterCard, and American Express are accepted. To pay their tuition, students may choose one of the following options:

- **Send a Personal Check/Money Order:** Make checks payable to: Curry College
- **Pay Online:** Curry College partners with Tuition Management Systems (TMS) to process credit/debit card and checking/savings account payments online. TMS accepts American Express, Discover, MasterCard and VISA cards. To pay online, simply log onto the TMS secure website at www.curryce.afford.com/paynow and select "Make a One Time Payment". Students can also access this online payment gateway directly from the Curry Web Portal. Credit and debit card transactions will have a service fee applied. A transfer payment from a bank checking or savings account will not incur a service fee.
- **Request a Payment Plan:** Graduate students enrolled in a cohort program can take advantage of a convenient payment plan available through TMS (Tuition Management System) at www.afford.com/curry. This tuition management payment option allows students to spread tuition payments over two or three semesters with only a \$55 fee.

Federal Student Loans
