Application Process

To receive priority consideration, submit all materials by July 15 to begin in Fall 2020. Applications received after July 15 will be reviewed on a space available basis.

MSN Program Tuition

The MSN program has instituted an attractive fixed tuition cost to help students better manage their tuition payments. Our fixed tuition allows students to enter the program knowing the full cost of their MSN tuition and not be subject to an additional tuition increase as long as they remain enrolled in their original cohort group. The MSN program charges no additional course fees and an Alumni Discount may apply for those who qualify. For planning purposes, the fixed tuition for MSN students entering in the Fall 2019 cohort was \$34,020 (approximately \$972 per credit X 35 credits). The Fall 2020 rate will be announced in May 2020.

Tuition Billing Process

Approximately five weeks prior to the start of the fall, spring, and summer semesters, students will be mailed a tuition bill for their semester coursework. Tuition payments are due within 30 days of the billing date specified on the bill and must be paid in full prior to the start of each semester.

Curry College offers a Direct Billing option for students whose employer or other third party organization will be paying the College directly for their classes. Students who plan to use the direct billing option are required to provide appropriate documentation, such as a purchase order or voucher. Tuition Payment

Tuition payments are due within 30 days of the billing date specified on your bill. Tuition can be paid by check or credit card. VISA, Discover, MasterCard, and American Express are accepted.

Federal Student Loans
