



## GET TO KNOW YOUR COVERIFIED APP

## REMINDERS:

- Please be sure you have uploaded your COVID vaccine record in the Coverified App at least 24 hours prior to your move in day or first days of classes for commuters.
- Please be sure you have uploaded your COVID test result in the Coverified App at least 24 hours prior to your move in day or first days of classes for commuters.
- Your CoVerified App front screen should have a **green cleared ribbon**
- Please be sure that your name, date, and test result are visible when uploading any record. Your documents will be rejected if your name, result, date are not visible.

## TROUBLESHOOTING:

- Uninstall the CoVerified app from your phone, then restart your phone. Once restarted, download the CoVerified app again and try to login.
- Is the email account correct? If you are using your Curry College email account, the option to reset the password does not work. If you need a password reset, you need to contact the Tech Center at 617-333-2911 or [support@curry.edu](mailto:support@curry.edu).
- Android users: Do you have the most recent version of OS? You should use the Google Play store to get the most recent APK: <https://www.coverified.us/download>
- Try clearing you browser history (Safari, Chrome, etc.) and try to log in to the app again.
- **If you can use the web version, the issue is not the account, it's the phone.**

## TESTING PROGRAM:

**Onboard testing is required for all members of the Curry community** (including all commuter and residential students regardless of vaccination status) before the start of the semester, as follows:

- **Fully Vaccinated Students:**

- Must conduct their own PCR tests off campus within the 72 hours prior to arrival, and provide a report of their negative test result via the CoVerified app before arrival. [Instructions on how to upload test results to the app may be found here.](#) **Your name and test result must be clearly visible when uploading test document.** Free testing is available at [CVS](#) and [Walgreens](#) pharmacies.

- **Unvaccinated Students with Approved Exemptions:**

- Must conduct their own PCR tests off campus within the 72 hours prior to arrival, and provide a report of their negative test result to the College via the CoVerified app before arrival. [Instructions on how to upload test results to the app may be found here.](#) **Your name and test result must be clearly visible when uploading the document.** Free testing is available at [CVS](#) and [Walgreens](#) pharmacies.
- In addition to your COVID test prior to arrival, a PCR test on campus will be required as part of the move-in process (for residents) or upon arrival (for commuters). Resident students will be allowed to move in once a negative rapid result has been received. A second on-campus PCR test will be required 72 hours after arrival.
- Weekly on-campus surveillance testing throughout the semester will be required only for unvaccinated individuals who have obtained exemptions. Student testing will be conducted at Cottage, and faculty and staff will conduct unobserved self-swab testing. Further details will be forthcoming. Please note that testing protocols may change due to changing campus or public health situations.
