

Curry College Health and Immunization Requirements

Follow the steps below to complete the health and immunization requirements.

Print this guide! Keep it nearby as a reference as you complete the steps!

Step 1: Set aside at least 60 minutes to complete the steps.

- Gather your immunization record, your insurance card and the contact information for your primary care provider PCP and other specialty provider(s).
- You will also need to know your allergies and the names and dosages of your current medications.
- It may be helpful to have a parent or guardian nearby that knows your medical history.
- Log into the Pyramed Health Portal. Log into my.curry.edu with curry email and password. Find and select the PyraMED icon under Quicklinks (links are alphabetical, scroll down). Once connected to Pyramed **Select the MY FORMS tab to see your required forms.**

Step 2: Forms. Complete the required online forms via the Pyramed Health Portal.

- Curry College Medical History Form
- Curry College Tuberculosis Screening Form
- Curry College Health Insurance Plan Form
- Curry College Immunization Form (See Step 3)

Step 3: Immunizations. Complete the immunization form and upload a copy of your official immunization records.

- Curry College Immunization Form. Enter the dates of all required vaccinations exactly as they appear on your official immunization record.
- Complete additional vaccination related forms if applicable: Meningococcal Vaccination waiver or Medical or Religious Exemption Forms.

Step 4: Uploads

- Upload your official immunization record to the Pyramed Health Portal via the direct links in the Immunization Form or via the DOCUMENT UPLOAD tab.
- Your immunization record needs to have your full name, date of birth, name and date that vaccines was given AND provider/clinic signature, stamp or letterhead. **A picture of your verified immunization record with provider/clinic information is acceptable BUT multiple screen shots from your phone without your identifying information or provider information are not acceptable.**
- Upload additional required information such as Insurance card (front and back).
- Upload additional information such as Antibody titers, TB blood test results, Consent for Medical Care for Students under the age of 18 if applicable.

Step 5: Verification

- You will ONLY be contacted if you have NOT met the requirements. Allow 7 days after submission of your forms for them to be reviewed and processed.
- Examples of unmet Requirements: You may need to provide missing vaccination information; you may need to supply a Consent for Medical Care Under age 18 Form; you may need to complete a Meningococcal Vaccination waiver; you may need Tuberculosis (TB) blood testing if your TB screening was positive. If needed, these forms are available in Additional Forms section.
- Verify that you have completed the steps by checking your Curry College email regularly for messages from healthservices@curry.edu. If you are missing a required step, it is your responsibility to complete it. **Your move-in day or your ability to register for classes may be impacted if you have not met the health and immunization requirements.**
